



Acumen Asset Management was established in 2010 under the umbrella of Acumen Holding with a paid-in capital of EGP 10 million. The company manages portfolios of public and private sector institutions, high net-worth individuals and mutual funds. Acumen Asset Management was able to acquire the mandate of managing Kheir fund after one year of its establishment, sponsored by Misr El Kheir foundation,

and the management of its first balanced equity fund launched after the January 2011 revolution, Ezdehar, sponsored by Audi Bank

The company is headed by Mrs. Rana Adawi who comes with prime expertise in Asset Management and over 24 years of experience in the financial services industry in leading international and regional financial institutions. Total assets under her direct management exceeded EGP 5bn. Mutual funds managed by her were ranked 1st through 3rd for 3 consecutive years (2005, 2006 and 2007) among all competing Egyptian funds.

Mrs. Adawi then founded Acumen Asset Management and is currently managing Egypt's top-performing funds "El Kheir Fund" and Bank Audi's Islamic Fund "Ezdehar", along with portfolios of public and private sector institutions and high net-worth individuals.
